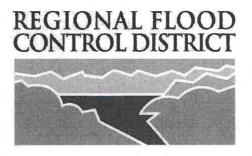

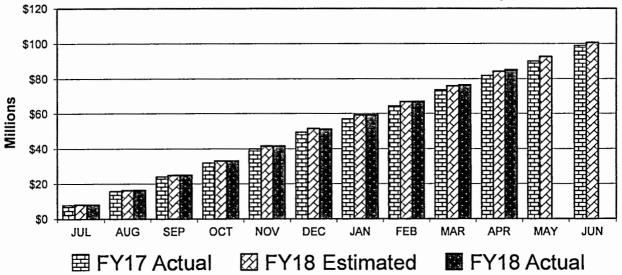

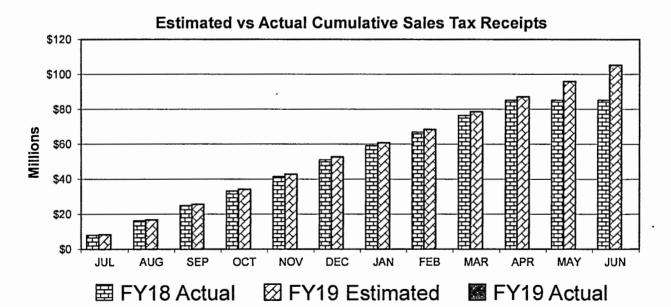

BACKGROUND:

The Tropicana and Flamingo Washes project was authorized for construction under the Water Resources Development Act of 1992 (PL 102-580, as amended). A Project Cooperation Agreement (PCA) was signed in 1995 between the Corps of Engineers and the local sponsors: Clark County Public Works and Clark County Regional Flood Control District. The project was constructed between 1995 and 2009 at a total cost of \$335 million. The project was fiscally closed in April 2011.

The F-4 Channel is one of the project features constructed as part of the Tropicana and Flamingo Washes project. On September 15, 2014, a significant rainfall event occurred that caused damage to a channel wall in the F-4 Channel. Approximately 60-feet of channel wall was severely damaged requiring replacement. The contract for the reconstruction work was awarded on July 28, 2015 and a notice to proceed for construction was issued on October 14, 2015. This work was managed by the Corps of Engineers (Corps) with all funds being provided by the Corps of Engineers authorized under the Rehabilitation and Inspection Program (PL 84-99).

CAC AGENDA ITEM #07 Date: 07/30/18 Based on field assessment of the channel and evaluation of the as-built drawings, a determination was made that the channel wall height transition beyond the limits of the failure was built using an incorrect rebar size and an incorrect wall thickness as a result of an incorrect detail on the original construction plans. Pursuant to Article VIII.A of the PCA, the County is required to operate, maintain, repair, replace and rehabilitate the entire Project or the functional portion of the Project at no cost to the Government. On February 9, 2016, the Corps of Engineers provided a letter to remove and replace this section of channel. Pursuant to Section 5c of Engineering Regulation 1165-2-119, funding for a repair or replacement as supported by an approved design deficiency report should be consistent with the cost sharing in the original project authorization. In accordance with the PCA, the Corps contributed 75% of the total project cost and the local sponsors contributed 25% of the cost. The Corps of Engineers' estimated a project cost of \$2,847,000.00. The local sponsor share was \$711,750.00.

The proposed work was a repair to an existing channel, which was eligible for funding from the Maintenance Work Program, in accordance with District policy. On March 10, 2016 the Board authorized the expenditure of \$711,750.00 in maintenance work for reconstruction of the F-4 Channel. Construction began in May of 2016 and completed in October of 2016. On June 22, 2018 the Corps of Engineers provided a letter (included in the backup) documenting the closeout of the design deficiency correction work for the F-4 Channel. The total project cost was \$1,573,940.18; The Federal share was \$1,180,455.14, and the local sponsor share was \$393,485.04. The District provided \$711,750.00 of which \$393,485.04 was expended, leaving \$318,264.96 remaining. The unspent monies have been refunded by the Corps.

This letter documents the closeout of the design deficiency correction work for the F-4 Channel of the Tropicana and Flamingo Washes Federal Flood Control Project located in Clark County, Nevada.

Pursuant to the Corps' Engineer Regulation (ER) 1165-2-119 "Modifications to Completed Projects," this design deficiency correction effort falls within the purview of the existing project authority: the Water Resources Development Act (WRDA) of 1992, Public Law 102-580, Section 101, part (13), 106 Stat 4797 (October 31, 1992).

On February 9, 2016, the Los Angeles District of the U.S. Army Corps of Engineers sent your agencies a letter explaining the intent to perform design deficiency correction work required after the September 15, 2014 storm event (enclosed). That letter identified the relevant Project Cooperation Agreement (PCA) and Amendments Number One and Number Two among the Department of the Army, and the non-Federal Sponsors, the Clark County and the Clark County Regional Flood Control District, for the construction of the Tropicana and Flamingo Washes Federal Flood Control Project in Las Vegas, Nevada, a cost-shared project. The PCA was executed February 7, 1995; Amendment Number One was executed December 17, 1999; and Amendment Number Two was executed March 28, 2007. Construction under this agreement began June 29, 1995 and was completed October 28, 2009. All project features have been completed and turned over to the non-Federal Sponsors.

On September 15, 2014, a storm event damaged two panels of the F-4 channel. These panels were repaired including both sides of the channel wall and the invert at

Federal cost under PL 84-99 (33 U.S.C. 701n), Flood Control and Coastal Emergencies Act (as amended). The design deficiency causing the channel failure was described in the Deficiency Correction Report for the F-4 Channel, dated July 2015. The report recommended corrective action of removal and replacement of the sections of the channel walls (both sides) and invert in from Station 25+61 to Station 26+64 (103 meters or 338 feet). Construction began May 2016 and completed October 2016.

The PCA required that your agencies cost-share the correction effort. The total project cost was \$1,573,940.18; The Federal share was \$1,180,455.14, and the non-Federal Sponsor share was \$393,485.04, in cash. Clark County provided \$711,750 of which \$393,485.04 was expended, leaving \$318,264.96 remaining, which will be refunded by EFT CWIS 012696. A financial summary of funds received and expended is attached for your records.

As a reminder, your agencies are required to jointly or independently resume the Operation, Maintenance, Repair, Replacement, and Rehabilitation (OMRR&R) activities mandated in the exiting PCA and as indicated in the project OMRR&R Manual, dated November 2010.

	THIS INTERLOCAL CONTRACT made and entered into as of the	day of

herein	after referred to as "DISTRICT" and City of Henderson, hereinafter referred to as "O	CITY".

WITNESSETH

WHEREAS, pursuant to Chapter 543 of the Nevada Revised Statutes, the DISTRICT may approve a project to design and construct flood control improvements, and;

WHEREAS, the flood control improvements proposed herein are the same as those generally identified in the 2013 Master Plan Update Structure No. WWDC 0001, 0016, 0031, 0034, 0053, 0056 and 0070, hereinafter referred to as "PROJECT"; and

WHEREAS, the PROJECT is identified and shown on the attached Exhibit "A"; and

WHEREAS, the PROJECT has been approved by the DISTRICT on its Ten Year Construction Program; and

WHEREAS, the PROJECT has regional flood control significance and is located in the same hydrographic area as the CITY, and the COUNTY OF CLARK.

NOW, THEREFORE, in consideration of the covenants, conditions, contracts, and promises of the parties hereto, the DISTRICT and the CITY agree to the following:

SECTION I - SCOPE OF THE PROJECT

This INTERLOCAL CONTRACT applies to design engineering and other costs associated with the Whitney Ranch Channel Replacement project. The basic improvements shall consist of flood water facilities including reinforced concrete boxes, channel structures, channel access and

other appurtenances as may be necessary to control floodwaters. The improvements shall be funded through DISTRICT funds as herein described. This project is further identified and shown on the attached Exhibit "A".

SECTION II - PROJECT COSTS

The DISTRICT agrees to fund project costs within the limits specified below:

- 1. The engineering and design shall not exceed \$336,800.00.
- 2. Environmental costs shall not exceed \$50,000.00.
- 3. CLOMR/LOMR costs shall not exceed \$50,000.00.
- 4. OTHER/Public Outreach costs shall not exceed \$12,000.00
- 5. The total cost of this Contract shall not exceed \$448,800.00 which includes all the items described in the paragraphs above.
- 6. If at any time during the term of this Contract the entity determines that a portion of the funds provided pursuant to this Contract will not be needed for the project, then the entity will notify the District in writing of the amount of funds that are not anticipated to be used for the project. Upon receipt of said notification the District's obligation to pay the maximum amount set forth herein will automatically be reduced by the amount specified in the notification.
- 7. A written request must be made to the DISTRICT and approved by the Board to reallocate funds between phases of the project. No other approval by the Lead Entity is required.

8. A written request must be made to the DISTRICT and a Supplemental Interlocal Contract approved by the Board to increase the total cost of the contract noted above prior to payment of any additional funds.

SECTION III - GENERAL

- The Clark County Regional Flood Control District shall be shown on the title sheet of both the plans and the specifications as the funding agency.
- 2. The CITY will comply with the Local Purchasing Act, Chapter 332 and Public Works Projects, Chapter 338, of the Nevada Revised Statutes.
- 3. The CITY, its employees, and representatives shall at all times comply with all applicable laws, ordinances, statutes, rules, and regulations in effect at the time work is performed on the PROJECT.
- 4. The CITY will require appropriate financial security for the construction of the PROJECT.
- 5. The CITY shall provide all impacted entities and the DISTRICT with the opportunity to provide the CITY with input relative to the following processes: scope of services development; consultant selection; design, construction and maintenance review; and monitoring of the effectiveness and impacts of facilities on flood flows.
- 6. Applicable portions of the current editions of the Policies and Procedures, the Hydrologic Criteria and Drainage Design Manual, and Uniform Regulations for the Control of Drainage adopted by the DISTRICT will apply in developing this PROJECT unless specifically superseded by this CONTRACT.
- 7. Purchases of right-of-way in excess of that actually needed for construction will not be allowed unless a comparison between the cost of excess acquisition and needed acquisition,

including damages, indicates that benefits from such a transaction would result. Title to residual property will be vested in the name of the CITY. Revenues derived from the sale of these properties, less the cost of the sale of these properties, will be forwarded to the DISTRICT.

- 8. Administrative settlements and acceptance of counter offers involving right-of-way may only be made following a review and approval by the DISTRICT.
- 9. The DISTRICT will pay the CITY, or make payment directly to its contractor or its consultant, each month for project costs as outlined in SECTION II PROJECT COSTS.
 Invoices must identify and allocate all costs to the categories noted below:
 - a. Right-of-Way acquisition including appraisals, title and escrow, negotiations, legal fees, recording fees, etc.
 - b. Predesign engineering (all work prior to design, excluding right-of-way)
 - c. Design Engineering
 - d. Construction Engineering
 - e. Construction (all work after award of construction contract)
 - f. Environmental: costs incurred by the Lead Entity for the preparation of environmental documentation applicable to the project and costs incurred for the implementation of mitigation measures provided in an environmental document (e.g., EIS OR EA).
 - g. Other including landscaping, flood insurance rate map amendments or revisions, etc.
- 10. Accurate documentation of all work performed and payments made will be maintained by the CITY for a period of three (3) years in hard copy form after final project approval and payment. Following the three-year period, the CITY shall keep records for permanent storage in original form, in microfilm/fiche media, or an electronic format.

- 11. The DISTRICT reserves the right to review and/or audit all records pertaining to all projects, both during and after project completion.
- 12. Up to the limits set forth in NRS Chapter 41, the CITY will indemnify and defend the DISTRICT against and from any and all claims and demands of whatsoever nature which arises out of allegations of negligence or misconduct of CITY officers, employees or agents, related to or under this Contract which results from injury or death of any persons whomsoever, or against and from damage to or loss or destruction of property.
- 13. Any costs found to be improperly allocated to this PROJECT will be refunded by the CITY to the DISTRICT.

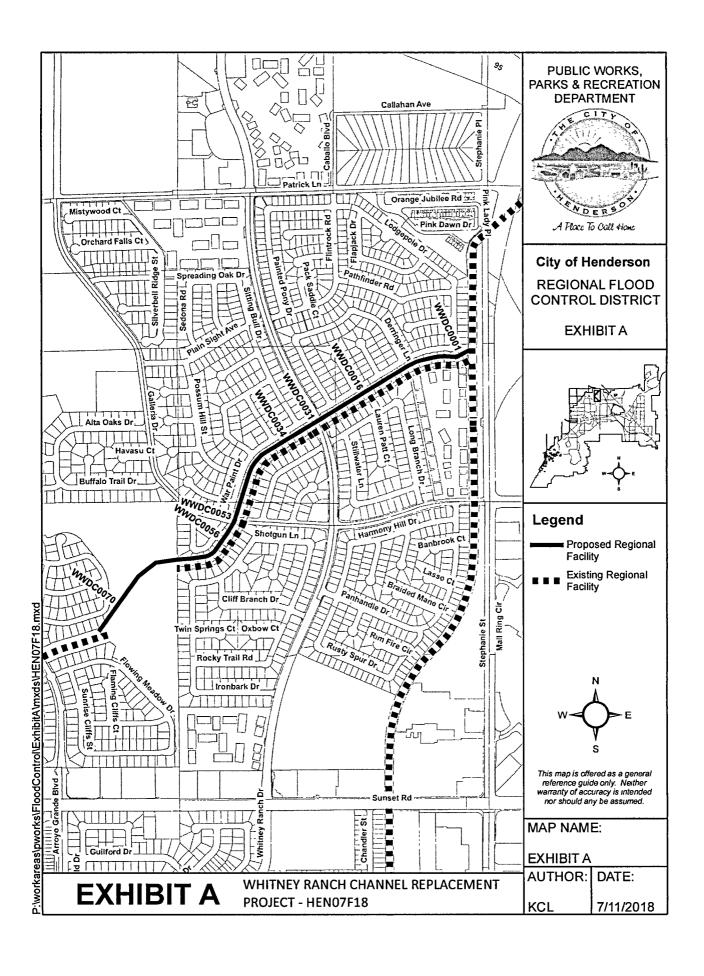

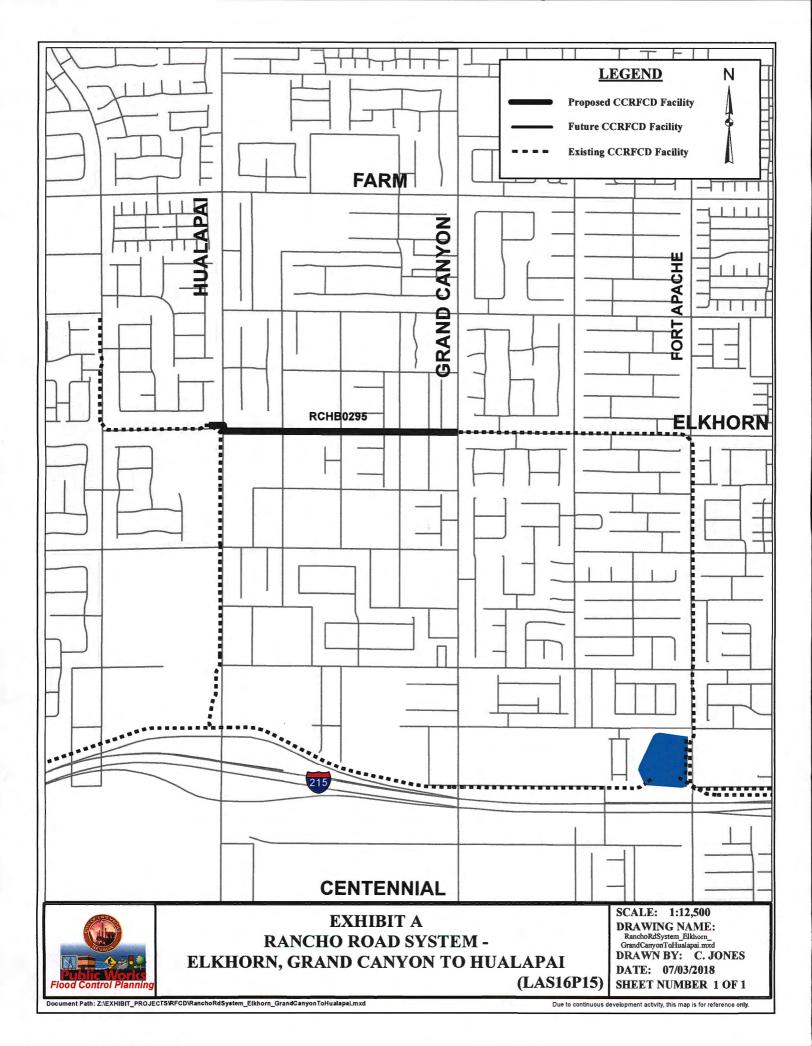
