#### 1. Call to Order.

The meeting was called to order by Steven Parrish, CCRFCD. A quorum was present.

#### 2. Comments by the General Public about the Current Agenda.

On March 22, 2020, the State of Nevada Executive Department issued the Declaration of Emergency Directive 006, which suspends the requirement contained in Nevada Revised Statute 241.023(1)(b) that there be a physical location designated for meetings of public bodies where the public can attend and participate. In accordance with the Notice of Public Meeting, public comments were accepted via email. The meeting was properly posted to the general public and the email provided was monitored prior to and during the meeting for comments. No comments received.

#### 3. Action to Approve the Agenda.

The proposed agenda was approved.

#### 4. Action to Approve the minutes of the February 9, 2021 meeting.

The meeting minutes from the February 9, 2021 SQMC meeting were approved.

## 5. Action to accept a presentation on the Coanda trash screen technology.

Steve Esmond (Water Shark Systems, LLC) provided a presentation about Coanda screens and how they are an effective water treatment system that assists companies and entities in cleaning their stormwater prior to discharge. The company has over 30 years of experience in stormwater engineering and treatment, and treating site specific issues, such as trash, sediment, metals, nutrients, COD, and bacteria. Discussion topics included how the Coanda effect works with tilted wedge wire screen technology, connector pipe screens (CPS), automatic retractable screens (ARS), and maintenance issues when cleaning is required. The Coanda screens have a large flow capacity and are hydraulically self-cleaning without moving parts (minimal maintenance). Coanda screens are corrosion-resistant, 100 percent stainless steel construction, and designed to remove 100 percent of the trash and sediment at peak flow.

Steve described project application examples such as the Coanda Channel Screen Santa Ana River, and the urban trash in Downtown of Los Angeles, CA. Coanda screens were able to capture not only trash and leaves but also mulch, sediment, and grass seeds. According to Steve, the Coanda screens life cycle is 30 to 40 years, and the cost to remove 1 lb of TSS is approximately \$0.48.

John Solvie (CC) informed the SQMC that Clark County is planning a pilot project funded through a grant from NDEP to test the Coanda screens and their effectiveness in the Las Vegas Valley.

# 6. Action to accept a presentation and receive an update on the Proposed Water Quality Standards for the Las Vegas Wash for Selenium.

John Tennert (CCRFCD) provided an update about the Proposed Water Quality Standards for the Las Vegas Wash for Selenium. CCRFCD met with the EPA to discuss establishing site specific criteria based on historical studies that have been completed. EPA requested additional sampling and the carp sampling is scheduled to start in August 2021. John also informed about a tributary analysis that will be performed in the tributaries to Las Vegas Wash.
